This work includes the development of internal laws, policies and processes for aboriginal communities and governments. Some of his litigation work has in-

cluded being legal counsel in Métis harvesting rights cases in Ontario, Manitoba, Saskatchewan and Alberta (Laurin & Lemieux, Goodon, Laviolette, Belhumeur, Hirsekorn) as well as being counsel for various Métis governments in all of the cases that have been decided by the Supreme Court of Canada over the last decade that involve Metis legal issues (Powley, Blais, Cunningham, Manitoba Metis Federation).

Jason is a regular speaker at conferences and law schools on aboriginal legal issues generally and Métis legal issues specifically. He has been published in books and journals on aboriginal self-government issues and Métis rights.
