Schedule C: MMF Night Hunting and Night Lighting Agro-Zone Boundary Map Notes

Reminder: Safety First!

Metis Harvesters must always remember to adhere to safe practices, including safe and responsible night hunting practices in Non-Agro Manitoba.

Note 1: Starting at the Saskatchewan and Manitoba border, the Boundary moves east along the border of GHA 13 and 13A. The Boundary moves north along the border of GHA 13 and 14, then moves northeast along the border of GHA 12 and 14. The Boundary departs from GHA borders and moves south along the municipal border of Mountain North until the northern municipal border of Minitonas. The Boundary moves east along the municipal border of Minitonas, and then south along the municipal border between Minitonas and Mountain South, until these borders intersect with the border between GHA 14 and 14A.

Note 2: The Boundary moves southeast along the border of GHA 18B and 14A and continues east following the border between GHA 14A and 19A. The Boundary departs from GHA borders and follows the eastern municipal border of Mountain South and the northern municipal border of Mossey River (moving along the Southern shoreline of Lake Winnipegosis).

Note 3: The Boundary follows the northern municipal borders of Lawrence and Alonsa (moving along the border between GHA 19B and GHA 20 & 25) until the municipal border of Siglunes.

Note 4: The Boundary moves north along the municipal borders of Siglunes and Grahamdale. The Boundary continues to move along the northern border of Grahamdale until it intersects with the border of GHA 16 and 21.

Note 5: The Boundary moves south along the municipal border of Grahamdale and, as it diverges from the municipal border, continues southwest along the border of GHA 16 and 21. The Boundary continues along the southern shore of Lake St. Martin until reconnecting with the municipal border of Grahamdale. The Boundary moves southeast along the municipal border of Grahamdale until the western municipal border of Fisher. The Boundary follows the northern municipal border of Fisher until it intersects with GHA 25. The Boundary follows the border of GHA 25 until reaching the northeastern corner of the municipality of Bifrost.

Note 6: The Boundary follows the northern border of N.W. ¼ SEC. 32 TWP. 25 RGE. 4 E.P.M. (Township & Range Grid) until reaching the shoreline of Lake Winnipeg and Hecla Provincial Park. The Boundary continues south following the shoreline of Lake Winnipeg and the municipal borders of Bifrost, Gimli, St. Andrews, and St. Clements.

Note 7: The Boundary follows the municipal border of Alexander, then Victoria Beach, and returns back to follow the municipal border of Alexander until reaching the border of Fort Alexander No. 3 Indian Reserve. The Boundary meets back up with the municipal border of

Alexander and follows its border east. The Boundary moves south along the western border of TWP. 17 RGE. 15 E.P.M., TWP. 16 RGE. 15 E.P.M. and TWP. 15 RGE. 15 E.P.M (Township and Range Grid) until intersecting with GHA 26 and 36. The Boundary follows the border of GHA 26 and 36, east, to the Manitoba-Ontario border.

Note 8: The Boundary follows the border of GHA 18 within Manitoba. GHA 18 is defined as Non-Agro Manitoba.
